***In-Parish Catholic Tuition** (Refer to **Tuition Policy** for definition)

An In-Parish Catholic Family, with three or more children living in the same household and attending Our Lady of Mercy School, is eligible for a *family* discount. The amounts reflect the total discount per family, not per child.

TUITION AND FEES *(continued)*

PAYMENT OPTIONS

These options include all tuition and fees with the exception of the application and re-enroll fees.

All fees (to include, but not limited to, grade level, technology, and supply fees) will be collected in the first month tuition is billed based on your payment plan selection.

- 1) Annual Payment Plan (non-financing option)
 - a) Pay the school in full by scheduling your one-time payment to be drafted in May through Blackbaud Tuition Management. No payment plan fee applies to this option.
- 2) Pay two semi-annual or 10 monthly payments (financing options)
 - a) Option to split payments into two semi-annual payments plus a payment fee of \$75 per payment due in May and November
 - b) Option to split payments into ten monthly payments plus a payment fee of \$31 per payment with the first payment due in June and ending in April. No tuition will be drafted in January as registration for the 2026-27 academic year is paid online this month.

Blackbaud platform fees apply as follows:

- Credit & debit card payments will be charged a 3.1% usage fee.
- ACH payments will be 1.0% + \$.30 per transaction, with a maximum of \$2.50 per transaction. The \$2.50 cap applies for any transaction of \$220 or more.
- Payments made directly to the school will not access a platform fee.

A late fee of \$40 per month will apply after a grace period of 10 days.

Per the handbook, students are not allowed to attend class if their account is past due.

TUITION / FEES REFUND POLICY

When withdrawing from Our Lady of Mercy Catholic School, tuition paid will be refunded according to a graduated scale as follows:

May 1 to May 31 - 100%,
June 1 to August 31 - 75%,
September 1 to December 31 - 50%,
January 1 to March 31 - 25%,
April 1 to May 31 - 0%.

No fees (to include, but not limited to, grade-level, technology, supply, etc.) are refundable as of June 1st. Families of students who are asked to leave the school for disciplinary reasons forfeit remaining tuition and fees.

The **application fee** of \$275 per student is non-refundable.

\$150 of the application fee will be refunded in the event Our Lady of Mercy is unable to offer admissions.

Re-enrollment fees are non-refundable.
